1. RESOLUTION 41-09 DECLARING THE MONTH OF OCTOBER 2009 TO BE "AMEND OHIO'S SOCIAL HOST LAW AND HELP PROTECT OHIO'S CHILDREN MONTH," IN THE CITY OF SOUTH EUCLID, OHIO, IN SUPPORT OF THE COALITION TO AMEND OHIO'S SOCIAL HOST LAW. FIRST READING.
