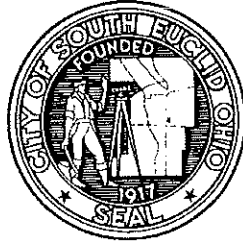

SNOW PLOW PERMITS SURETY BONDS

All companies and/or individuals obtaining a City of South Euclid snowplow permit must produce a surety bond that covers that company or individual. If at the time of application, the surety bond covers only a portion of the snowplow season, which is the date of issuance through May 15, then said company or individual will submit a current surety bond when the previous bond expires as soon as possible. If a current bond is not on file in the South Euclid Police Department within 10 days of expiration, the permit will be subject to criminal penalties pursuant to South Euclid Codified Ordinance 1143.01.

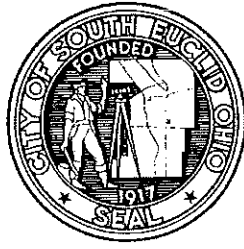

SNOW PLOW PERMITS CUSTOMER ADDRESSES

All companies and/or individuals obtaining a City of South Euclid snowplow permit must produce a list of the addresses of the properties to be served by said company or individual through out the permit period according to South Euclid Codified Ordinance 1143.01 (e). Companies will have until December 15 to supply the City of South Euclid a list of all addresses of the properties to be served by said applicant throughout the said permit period.

I hereby agree to the above terms and agree to submit a list of all properties to be served throughout the said permit period. I also understand that if I fail to provide the necessary information, I will be charged under South Euclid Codified Ordinance 1143.0.01 (e) which will require a mandatory court appearance in the South Euclid Municipal Court and may result in the cancellation of my snow plow permit in the City of South Euclid.

NOTICE

TO ALL PERSONS PLOWING SNOW WITHIN THE BOUNDARIES OF THE CITY OF S. EUCLID

TO WHOM IT MAY CONCERN

Codified Ordinances of South Euclid are as follows:

1143.01 PERMIT REQUIRED; FEES

(a) Any person, firm or corporation using a vehicle to remove snow from private driveways and/or parking lots in the City for a fee or charge of any kind shall secure a permit from the Department of Police of the City prior to doing any snow removal.

(b) Prior to the issuance of each permit, each applicant shall furnish the make, model and serial number of the vehicle to be used; and the name, address and telephone number of the owner and/or operator employed. Each applicant shall pay the sum of twenty-five dollars (\$25.00) for the first motor vehicle and ten dollars (\$10.00) for each additional motor vehicle for such permit which shall cover a period extending from the date of issuance to May 15 following the issuance thereof. (Ord. 23-84. Passed 10-22-84.)

(c) Bond Required. Prior to the issuance of each permit, each applicant shall also execute and file with the Director of Finance a good and sufficient bond in the sum of two thousand five hundred dollars (\$2, 500), which bond shall be subject to approval of the Director of Law and shall be conditioned upon the faithful performance of all contractual arrangements, whether oral or written, entered into by such applicant with residents of the City for snow removal and to indemnify such residents for any and all loss sustained by reason of any misrepresentation or breach of such contract or arrangement, and to indemnify the contracting owner or resident of the property being serviced by such applicant for any and all damage to the premises and further to indemnify the City for any and all damage or loss sustained by reason of snow removal by the applicant. (Ord. 39-83. Passed 10-8-84.)

(d) Prior to the issuance of each permit, the individual, firm or corporation seeking the permit shall be required to provide proof in the form of a signed affidavit, that the individual, firm or corporation does not have any outstanding judgments against them, in this or any other jurisdiction within the State of Ohio, relating to the operation of their snow plowing/removal business. The person signing the affidavit must be the individual or an officer of the corporation or legal entity seeking the permit. The City may refuse the issuance of any permit or revoke a previously issued permit for good cause shown. (Ord. 65-95. Passed 11-13-95; Ord. 47-04. Passed 7-26-04.)

(e) Prior to the issuance of each permit, each applicant shall furnish, in addition to those requirements set forth in subsection (d) hereof, the commercial license plate number for each vehicle, proof of insurance or financial responsibility, and a list of the addresses of the properties to be served by said applicant which shall be supplemented throughout said permit period.

521.04 STREET AND SIDEWALK OBSTRUCTIONS: DAMAGE OR INJURY

(d) "No person removing snow from any driveway, sidewalk, public or private parking lot or private premises within the City shall deposit the same on the street, pavement or sidewalk of any public street or on any treelawn in any public street except the treelawn immediately in front of the premises from which the snow is removed and in the event the treelawn is inadequate to accommodate the removed snow, or if there is no treelawn, then the snow being removed shall be deposited on the front or rear yard of the premises. (Ord. 47-84. Passed 11-26-84)

1550.16 OBSTRUCTION OF FIRE HYDRANTS

No person shall in any manner obstruct any fire hydrant in the City by placing or permitting to exist any material in front thereof from the curb line to the center of the street or to within five feet of either side thereof. No person shall allow the growth of grass or weeds, or the accumulation of snow, to cover or block the use of fire hydrants. Whoever violates this section is guilty of a misdemeanor of the first degree. Punishment shall be as provided in Section 1510.99
